3. FOR AN ADDITIONAL FEE ON TRANSFER AND WEIGHT INCREASE SUBTRACT THE \$1.50 STATE INSPECTION AND THE \$4.25 EMERGENCY MEDICAL SERVICE FEE FROM EACH PRORATED FEE AMOUNT AND \$3 MOTORCYCLE SURCHARGE AS APPLICABLE.
