Virginia Abandoned Motor Vehicle law (VA Code §46.2-1202).

INSTRUCTIONS

The vehicle, trailer or manufactured home must have a valid and legible Vehicle Identification Number (VIN)

If the vehicle, trailer or manufactured home is titled, complete Sections 1, 2 (if applicable) and 3.

If the vehicle, trailer or manufactured home is sold, complete Sections 1, 2 (if applicable), 3 and 4.

If the vehicle, trailer or manufactured home is transferred to a licensee for demolition or parting out, in accordance with VA Code § 46.2-1202, complete Sections 1, 2 (if applicable), 3 and 5.

- Section 1: The person or authorized agent in possession of the abandoned vehicle, trailer or manufactured home completes the vehicle and applicant information, enters the abandoned vehicle process receipt number and signs.
- Section 2: The licensed vehicle remover completes and signs this section if the vehicle is towed. DMV must receive the original VSA 40 form.
- Section 3: The person or authorized agent in possession of the vehicle, trailer or manufactured home must indicate his or her intent to title, sell or transfer the abandoned vehicle, trailer or manufactured home for demolition.

 Applicant signature certifies compliance with the Virginia Abandoned Motor Vehicle law.
- Section 4: If the abandoned vehicle, trailer or manufactured home is sold, the seller must complete and sign this section to certify compliance with the Virginia Abandoned Motor Vehicle law. Seller provides the purchaser with this completed and signed form and the Abandoned Vehicle Record Request receipt. Purchaser must submit this VSA 40 form, an Application for Title and Registration (VSA 17A) or Application for Certificate of Title Manufactured Home (VSA 17B), the Abandoned Vehicle Record Request receipt, and required fees to DMV at the time of titling. DMV must receive the original VSA 40 form.
- Section 5: The person or authorized agent transferring possession of the abandoned vehicle, trailer or manufactured home to a licensed demolisher or scrap metal processor signs this section and transfers this form with the abandoned vehicle to the demolisher/scrap metal processor. The licensed demolisher or scrap metal processor completes this section to certify that the abandoned vehicle, trailer or manufactured home was demolished or scrapped. A license number, signature, date and telephone number are required. The licensed demolisher or scrap metal processor returns this form to DMV along with proof of ownership (i.e., Abandoned Vehicle Record Request receipt, bill of sale, sales receipt, etc.). A copy of this VSA 40 form must be retained by the demolisher/scrap metal processor in accordance with the requirements in VA Code § 46.2-1206. DMV must receive the original VSA 40 form.

The demolisher returns the original VSA 40 form and, for vehicles manufactured for the 2002 model year and before, the Demolisher and Mercury Switch Removal Declaration form (VSA 44A) to DMV at:
