



RICHMOND, Va. (WWBT) -The Virginia Department of Transportation plans to realign the lanes on westbound Hull Street Road at southbound Chippenham Parkway to give drivers in the left turning lane more room.

That change will be implemented this summer.

1 killed, 2 injured in four-car crash on Hull Street Road

VDOT also says crews will adjust the traffic signal at the intersection to give those turning left from westbound Hull Street Road to southbound Chippenham Parkway a green arrow so drivers won't have to dodge eastbound traffic.

That change is also expected to be completed this summer.

Advantages

- Large dataset to analyze

Disadvantages

- Focused on major roadways
- Possibility of missing smaller areas that may be better enforcement candidates


Project Overview



Existing Conditions - Looking East From Old Hundred Road

Anticipated Total Cost - \$4,351,063

Purpose — Converting existing stop controlled intersection to a roundabout and providing pedestrian accommodations



From - 0.09 miles west of Route 667 (Otterdale Rd.)

To - 0.08 miles east of Route 667 (Otterdale Rd.)

Total Length — 1,055 linear feet (0.20 miles)

Old Hundred Road

Traffic Data -Old Hundred Road: 5,795 vehicles per day (2018) 14,720 vehicles per day (2040)

Otterdale Road: 3,420 vehicles per day (2018) 11,370 vehicles per day (2040)

Conclusion

- Enforcement resources are limited and need to be data driven
- Precise crash location data is invaluable
