

Commercial Motor Vehicle Inspection Requirements

Virginia law states that any commercial motor vehicle, subject to regulations of the Federal Motor Carrier Safety Administration (FMCSA), that is registered in Virginia and operates in interstate commerce, and is found to meet the federal requirements for annual safety inspection, shall be deemed to be in compliance with Virginia safety inspection laws.

No Sales and Use Taxes

Trucks, tractor trucks, trailers or semi-trailers, with a gross vehicle weight rating or gross combination weight rating of 26,001 pounds or more, are exempt from the 4.1 percent motor vehicle sales and use tax.

Permanent Power Unit Plates

Permanent plates on power units require an annual or biannual registration fee but there are no decals to track. Plates are embossed with the word "Permanent." Personalization on permanent plates is available on power units for an annual fee of \$10.

Permanent Trailer Plates

Permanent plates are available for all trailers, regardless of weight, for a one-time fee of \$100. No additional registration fees are required for the life of the registration. Permanent trailer plates are not transferable nor refundable. Personalization is available on permanent trailer plates for a one-time fee of \$10.

To better serve our motor carrier customers, Virginia DMV also offers International Registration Plan (IRP), International Fuel Tax Agreement (IFTA), over dimensional hauling permits, over load permits, assistance with vehicle size and weight requirements and free advice or training.
