INSTRUCTIONS

1. Plates, either personalized or regular, will be issued only for use on passenger vehicles, pick-up or panel trucks.
2. The Department of Motor Vehicles (DMV) cannot honor a change of choice or request for refund after the order has been sent to the manufacturer.
3. DMV reserves the right to refuse to issue objectionable combinations of characters.
4. The personalized license plate fee is \$10.00 annually in addition to the \$25.00 fee and the regular annual registration fee. The personalized license plate fee will be prorated based on the number of months remaining in the current registration period not including the current month.
5. The owner of these plates can take advantage of the multi-year renewal option provided the Uninsured Motor Vehicle Fee is not required. To **RENEW FOR TWO**, simply double all fees.
